Call to Order:

Mayor Turner called the meeting to order at 7:00 p.m.

Roll Call:

Roll call was answered by Councilman Robert Blankenship, Councilwoman Monica Gearding, Councilman Robert Arnold, Councilman Robert Honaker and Councilman Bradley Jones.

Approval of Minutes:

Upon motion of Councilman Blankenship seconded by Councilman Honaker to approve the Minutes of July 1, 2013 Regular Meeting. Mayor Turner called for a vote. Motion carried unanimously.

Incoming and outgoing correspondence copied to Council prior to the meeting.

Reports Presented:

Financial Reports

General Fund ending 6/30/2013

Upon motion of Councilman Blankenship seconded by Councilman Arnold to Approve financial reports and authorize payment of bills for General Fund Ending 06/30/13. Mayor Turner called for a vote. Motion carried unanimously.

- Attorney Verst advised that there were no Ordinances or Resolutions to present.

Citizen's Comments:

Mayor's Comments:

Councilman Blankenship

- Asked Chief Williams how the progress was going in regards to the police patrol at the Stop sign @ Johns Hill Road and Feldman Lane.

Chief Williams advised that the officers are still there and have not issued any citations.

- Questioned when the dredging would be completed.

Mayor Turner stated that the maintenance department is currently repairing the dredge.

Councilman Arnold

- Questioned if Display Specialty property would be able to receive a larger water line.

Discussion ensued regarding the water line and sprinkler system.

Councilman Jones

- Questioned if the lack of a sprinkler system is prohibiting a business from locating there.

Mr. Vance said that the sprinkler system is there but doesn't feel it would put out the type of fire that could happen in that building.
