The regular meeting of the Wilder City Council was held on Monday, October 7, 2013 at the Wilder City Building, 520 Licking Pike, Wilder, Kentucky 41071.

Call to Order:

Mayor Turner called the meeting to order at 7:00 p.m.

Roll Call:

Roll call was answered by Councilman Robert Blankenship, Councilman Brack Herald, Councilman Robert Arnold, Councilman Robert Honaker and Councilman Bradley Jones.

Approval of Minutes:

Upon motion of Councilman Blankenship seconded by Councilman Herald to approve the Minutes of September 16, 2013 Regular Meeting. Mayor Turner called for a vote. Motion carried unanimously.

Mayor Turner introduced Marc Barone with Woodman of the World Life Insurance presented the city with 10 U.S. Flags. Woodman of the World gives flags to any city or non-profit organization that is in need of them.

Mayor Turner Introduced Kristine Frech with The Licking River Greenway & Trails who was present to follow up on the grant opportunity through Vision 2015 that was presented to the city at the last council meeting.

Mr. Vance informed council that the engineers estimate for gravel and excavation of the trail was \$97,595.00.

Discussion ensued regarding the bidding process and the location of the trail.

Councilman Blankenship asked if there would be more grants in the first or second quarter of next year.

Ms. Frech has submitted for additional opportunities next year, however, their budget is on a calendar year so she will know later this year.

Mr. Vance asked if there would be a written agreement between Vision 2015 or Fiscal Court?

Ms. Frech said the agreement would be with Vision 2015.

Mr. Vance advised that we will invoice them for the \$40,000.00 once we have spent the total \$40,000.00.

Discussion ensued regarding the cost of the remaining trail.

Upon the motion of Councilman Blankenship seconded by Councilman Herald to enter into an agreement with Vision 2015 to match the grant of \$40,000.00 for the implementation of the bike trail. Mayor Turner called for a vote. Motion carried unanimously.

Mayor Turner called for a vote. Motion carried.
