Mayor Turner presented **Ordinance No. 16-1001: An Ordinance Repealing Section 93.01 (A) (13) Firearms. No Person Shall Carry or Discharge Firearms, Slings, Bows, or Any Other Device By Which Persons, Animals, or Birds May Be Injured or Frightened, and No One Shall Throw Stones or Other Missiles Within Park Property Except With Written Permission of the Commission.**

Mr. Vance advised of the state law change a few years ago and stated that it needed to be passed in order for the city to comply with state laws.

Discussion ensued regarding the change in the ordinance.

Councilwoman Gearding stated for the record that she is against this, however, she will vote to approve this ordinance so that the city is not in violation of state regulations.
